## **Contract Zoning**

Nancy Lightbody updated the Commission on the status of the Contract Zoning plan.

#### **Pesticide Restriction Ordinance**

The Commission considered next steps in developing the Falmouth Pesticide Restriction Ordinance. There was a discussion about enforcing a town pesticide ordinance. The Commission agreed that it is important to pursue a multi-pronged approach, one that includes educational programs, a restriction ordinance, and an advisory committee. Rich Bicknell and Susan Gilpin will work with Kimberly Darling to draft a Falmouth Pesticide Restriction Ordinance modeled on the South Portland ordinance. It was suggested that a team from the town attend the Northeast Organic Land Care Training Workshop held at Unity College next November.

#### **Lawns and Lobsters**

Nancy Lightbody reviewed plans for the upcoming "Lawns and Lobsters" educational program to be held at the Portland Country Club on March 10, 2018 from 9:00 a.m. until 12:00 p.m. The Cumberland County Soil and Water District will offer a follow-up program about maintaining safe lawns at the Falmouth Memorial Library on April 3, 2018, from 6:00 p.m. until 7:30 p.m.
