- 1. Approval of the minutes from March 12th 2015 Meeting.
 - a. Councilor Hemphill moved to approve the minutes, Councilor Anderson seconded. Motion carried 2-0.
- Presentation of proposed FY 2016 Town Budget.
 - a. Nathan Poore presented a Power Point summary of the FY 2016 Budget proposal that highlighted the budget challenges and solutions that produced a Mil rate reduction of .04 to the Town portion of the tax rate.
 - b. There was much discussion during the presentation regarding the contents of the budget and specific questions regarding components of the budget. The following are the significant discussion points and follow-up items:
 - i. There was a request to change the wording of the EMS part-time salary to make it clear that it was not a wage reduction but simply fewer hours needed due to a new full-time position.
 - ii. On slide 4 there was a request to change the wording of the bullet regarding reduced reliance of professional services. The bullet should read "reduced professional services expenditures due to the completion of the EnCode project.
- 3. Presentation of the proposed FY 2016 School Budget.
 - a. School Board Vice Chair Lucy Tucker presented a Power Point summary of the proposed FY16 Falmouth Schools Budget.
 - b. There was much discussion during the presentation regarding the contents of the budget and specific questions regarding components of the budget.
- 4. Nathan Poore the presented a 5 slide summary of the Total FY 2016 Budget
 - a. There was a request to re-work the Compound Annual Growth slide to make it more understandable to the general public.
 - b. There was a request to rework the overall Mil Rate Summary slide to include dollar impacts to homes valued at \$300K, \$400K and \$500K.

- 5. There was then a discussion of the April 9th presentation.a. The school will present first followed by the Town presentation.
