Elect a Chairperson

Charlie McBrady nominated Ned Kitchel to serve as Chairperson, Andrea Ferrante seconded. Ned Kitchel was elected Chair of the Finance Committee.

- Audit Presentation by Runyon, Kersteen, Ouellette (RKO)
 - a. Hank Farrah from RKO presented the audit goals, process, timing, areas of concentration and current progress.
 - i. There was a group discussion. Hank answered questions about audit scope and areas of focus and recommended that we schedule a preaudit meeting for next year's audit sometime in the spring 2017.
 - ii. A tentative date for the pre-audit meeting was set for April 24 at 5:30PM.
- Review of Budget Development Schedule
 - a. Nathan Poore went through the schedule of the 6 upcoming Finance Committee meetings including agenda topics and timing.
 - i. The group agreed that the addition of a March 23, 2017 meeting for a joint Town Council/School Board School Budget Workshop was a good addition to the schedule.
 - ii. Staff will check all dates against religious holidays to be sure there are no conflicts.
 - iii. Staff will notify the Library that their budget review is scheduled for January 11, 2017
- Presentation of Proposed Audit Procurement Policy
 - a. Nathan Poore and Pete McHugh presented the proposed new policy for Audit Procurement and a draft of the RFP that will be used.
 - i. Based on the GFOA recommendations for audit procurement, the new policy calls for issuance of an audit procurement RFP be done every 5 years and contains a provision that if the current audit firm wins the bid, that a new partner be put in charge of the audit.
 - ii. The proposed RFP was based on recent RFPs from the City of South Portland and the Town of Scarborough.

- iii. Ned Kitchel moved to approve the new policy with a second from Andrea Ferrante. Finance Committee voted unanimously to approve the new policy.
