Invasive Species

LPAC is the primary advisory committee to the Council on long range planning. Its current work consists of preparing Comprehensive Plan recommendations for the Town Council to help guide decision-making regarding Falmouth over the next ten years. Other work may include major ordinance work to implement the Comprehensive Plan and other tasks as assigned by the Council.

2012 Accomplishments

- Met 22 times. In addition, there have been numerous subcommittee meetings.
- Developed 13 draft chapters covering all required data topics including proposed goals, policies, and actions.
- Developed a vision statement.
- Developed draft maps.
- Held discussions with Town Manager, Executive Director of the Southern Maine Area on Aging, and the Community Development Committee.
- Held discussions with two dozen realtors, developers, and architects concerning future real estate development in Falmouth.
- Conducted on-line outreach with the public using feedback forms for each draft chapter. A total of 572 responses were received on 14 draft chapters.

2012 Accomplishments

- Permanently protected 93.7 acres of undeveloped land between Blackstrap ridge and Mast Road, an area now known as the Suckfish Brook Conservation Area. 65-acres of the property are wetlands, including the brook, a beaver pond and northern peat bog, making it one of the most valuable wildlife habitat areas in the town's inventory. The bulk of the funding for the acquisition came from the Maine Natural Resources Conservation Program (mitigation fund, (\$182,800), with support from the Casco Bay Estuary Partnership (\$20,000) and the Town (\$30,000). Included in that project was the restoration of a severely eroded woods road. The entire property is protected by a conservation easement held by the Falmouth Land Trust.
- Acquired a 134-acre parcel that lies between Blackstrap Hill Community Forest and the North Falmouth Community Forest, incorporating that acquisition into the latter property. This acquisition more than doubled the area of NFCF to 238-acres, making it the third largest block of open space land in town. The acquisition was done as part of an agreement with the National Park Service's Land & Water Conservation Fund to mitigate the loss of conservation property on the former elementary schools site. All \$1.16 million of the purchase price came from town funds
- Built over eight miles of new trails on various conservation and abutting private properties, including Hadlock Community Forest, Blackstrap Hill Community Forest, and the Suckfish Brook Conservation Area. A parking area was also constructed at Suckfish Brook, opening the area up to public use. A new trail on private land now connects Hadlock Community Forest to Blackstrap Hill Community Forest / Preserve. This has been a long-term objective for the Town that has finally been realized. The Cross Falmouth Trail now runs continuously from Community Park to Blackstrap Road, and will soon reach the Lowell Preserve in Windham. Two miles of trails were built on private land abutting Suckfish Brook Conservation Area. The Town now has over forty miles of trails on various open space properties, up from less than ten miles five years ago. Funding for nearly all of this trail work has come from various grants and donations.
- Volunteers also hardened and improved several miles of existing trails on various open space parcels by building new bog bridges or rerouting problematic sections. Good participation by the mountain bike community contributed greatly to all trail building and maintenance efforts.
- Over 75 volunteers donated 1,490 hours of time to various trail building and other land management projects. The value of that time is calculated to exceed \$40,000 if town employees had to do that work.
- The Ombudsman and two Conservation Corps volunteers were licensed as Master Pesticide Applicators by the State of Maine. With funding from the Casco Bay Estuary Partnership for the equipment and supplies needed, they and several other volunteers eliminated an estimated 1,200 invasive plants on the River Point Conservation Area property, including bittersweet, honey-suckle, buckthorn, multiflora rose, barberry, autumn olive and purple loosestrife. These plants were on the verge of taking over several areas of the property had they not been eliminated.
- Organized a 6th grade field experience for Falmouth Middle School students that had them measuring tree growth and regeneration on Hadlock Community Forest sample plots.

- Posted signage on various Town and Land Trust properties regarding trailheads, directional maps, boundary markers, etc.
- Conducted a BioBlitz activity in partnership with the Biodiversity Research Institute in June at the River Point Conservation Area in an effort to identify all the flora and fauna present on the property at that time of year. About 70 people participated in this event and many species were identified, including three rare plants that grow on the property. Also conducted several other public activities with Community Programs and the Falmouth Land Trust, including a *Hadlock Discovery Day* that drew over 40 people on a very cold and windy February day.
- Promoted a bird migration research project conducted at River Point Conservation Area by the Biodiversity Research Institute.
- Received contributions for Falmouth Conservation Corps work from Wal-Mart (\$1,000) and the Falmouth Lions Club (\$500).

Summary of ongoing duties, tasks, charge, etc.

Our purpose is to implement the five goals specified in *The Greening of Falmouth:*

- 1. Retain and protect Falmouth's rural character and natural resources,
- 2. Protect large tracts of land for wildlife habitat,
- 3. Insure the availability of outdoor recreation,
- 4. Provide connectivity between open space areas, and
- 5. Actively manage open space to benefit all citizens of Falmouth.

To accomplish these goals we plan, acquire, manage, and communicate. More specifically, we

- > Set strategic direction;
- Collect and manage data;
- ➤ Identify and assess key properties for acquisition;
- Create strategies for acquisitions;
- > Create and implement management plans for acquired properties; and
- ➤ Communicate with town officials, other organizations and the public.

- Work with the City of Westbrook to acquire 37-acres that abuts the Suckfish Brook Conservation Area, and which includes a large portion of the northern peat bog habitat.
- Construct a raised bog walk on the southern end of Suckfish Brook, plus a parking area and additional trails on the abutting Westbrook property.
- Construct new trails in the Woods Road Community Forest, and trails to the east of that property to connect to three other town owned parcels and link to six subdivisions.
- Construct new trails in the newly acquired portion of North Falmouth Community Forest that link it to Blackstrap Hill and complete the Cross Falmouth Trail.
- Facilitate the transfer of the forest management responsibility for Woods Road Community Forest from The Woodlands Club to the Town.
- Establish canoe launch sites on Field and Blackstrap Roads.
- Continue to improve and harden existing trails in places needing such work.
- Implement the forest management plan for Blackstrap Hill Community Forest and northern Community Park.
- Acquire a 14-acre parcel abutting Hadlock Community Forest and a 10-acre property abutting North Falmouth Community Forest. Respond to other acquisition opportunities as they arise.
- Complete development of management plans for each of the Town's major conservation properties and send to the Town Council for approval.

- Continue to inform the public about our work.
- Several major challenges lie ahead, including replacement of the River Point access bridge and creating a trail linking the school complex with Community Park (which involves a substantial bridge over the East Branch and a tunnel under the RR).
- Sort out the roles and responsibilities between our sub-committee and the Land Management Team.

2012 Accomplishments

• Chris Orestis is our new Council Liaison.

- Judy Currier continued to attend council meetings to update the committee with regard to the pending sale of the School Complex (a continuation of her work on the Community Facilities Planning Committee). A complete inventory of the abandoned schools was done by Community Programs staff and committee members assisted staff at two public auctions/sales that were held at the school complex site.
- In May, the committee was invited to an informative tour of the Town parks, open spaces and facilities lead by Community Programs Director Lucky D'Ascanio and Assistant Director Matt Gilbert. This year, the tour focused on the Mason-Motz facility to give the committee an idea of how this new space was being utilized.

2012 Accomplishments

- Conducted 12 meetings.
- Processed 56 development applications and issued 36 approvals to applicants.
- Held nine public hearings on proposed amendments to the Zoning and Site Plan Review Ordinance.
- Some of the more noteworthy final approvals granted in 2012 include:
 - Site Plan Approval of a new woodchip boiler for the Falmouth Middle School Woodville Road.
 - Site Plan Approval for an expansion of St. Mary's Church Foreside and Waites Landing Roads;
 - Preliminary Approval for the redevelopment of the former elementary school campus by Oceanview Retirement Community – Lunt and Middle Roads.

2012 Accomplishments

- Presented three home energy workshops led by regional energy efficiency and weatherization professionals through Falmouth Community Programs: Building Science, Fixing the Leaks, and Construction of Reusable Interior Storm Windows.
- Nominated and received ecomaine's Eco-Excellence awards for Gorham Savings Bank and Falmouth Elementary School.
- Recruited four new active committee members.
- Advised staff regarding small business recycling program subsequent to silver bullet removal.
- Completed inventory of Falmouth Green Ribbon Commission's recommendations, prioritizing and assigning responsibilities for recommendations. A number of recommendations have been completed through work of the committee and staff. In other cases, work is ongoing, projected or deferred.

Summary

The Board conducted 11 regular meetings and one site walk, hearing a total of 56 separate applications and appeals (note: some matters may involve multiple separate but related applications). The majority of matters involved applications to enlarge nonconforming structures or uses; there were also several other types of conditional use applications, and some variance applications and appeals.

Summary of Duties

- The Board is constituted under Ordinance § 8 and 30-A M.R.S.A. § 4353.
- The majority of matters heard by the Board are applications for conditional uses under Ordinance §§ 6 & 8 3
- The Board also hears applications for variances under Ordinance §§ 8.4-.6.
- The Board also hears appeals (1) from decisions of the Code Enforcement Officer under Ordinance § 8.2, and (2) where a single family dwelling is mislocated and violates setbacks under Ordinance § 8.2.1.
- The Board consists of five members and one or two associate members (who act if regular members are unable), all serving three year terms. Ordinance § 8.1(a).
- The Board was fully staffed with five members and two associate members throughout 2012. Donald Russell and Rudy Israel (both associate members) have departed the Board, and Roland Beaudoin has joined the Board as an associate member, effective in January, 2013. Consequently, the Board currently has one vacancy for an associate member.
- The Board receives, relies upon and appreciates extensive assistance provided by staff members of the Town's Code Enforcement and Community Development Offices, including: Justin Brown, Code Enforcement Officer; Amanda Stearns, Community Development Director; Patrice Perreault, Code Enforcement Administrative Assistant; and, Dawn Emerson, Recording Secretary.

Work Plan; Goals

- The Board will continue to meet on the fourth Tuesday of every month (normally excepting December), with additional meetings if necessary to address unusually heavy volumes.
- The Board may conduct one or more workshops if merited to address issues of significant interest or concern.
- The Board continuously strives to resolve matters promptly and in compliance with the Ordinance's requirements.
