Approved Meeting Notes

Tuesday, February 11, 2020

- 1. **Call to Order** John called the meeting to order at approximately 8:30 (NOTE: John attended the meeting by phone. John did not vote on any items.)
- Elect Vice Chair John discussed the need for a Vice Chair for situations where he is not available. Fred moved to create the office of Vice Chair. With a second by Chris the motion was approved. With a motion by Fred and a second by Dave, Chris was nominated for Vice Chair. No other nominations were made. With a motion by Fred and a second by Dave, Chris Kittredge was elected Vice Chair.
- 3. **Property Evaluation Process Statement** Amanda explained that the draft process statement was recommended by the Town Attorney. This statement will explain the use of executive session by the committee and the role of site walks. With a motion by Chris and a second by Fred, the statement as drafted was approved with the addition of citing the statute in the title and amend the statement to reflect only the use of executive session.
- 4. **Property Rating Guides Update** Sami presented the draft guide and the changes made due to the incorporation of the goals from the Open Space Plan. The update of the guide is a key recommendation from the plan and LMAC prioritized it for completion this year. The committee has a robust discussion and ultimately concluded that the draft would be amended to reflect Dave's suggestion of adjusting the guide to have a total of 100 points. The committee reviewed the relative scoring of each item and made some modifications. Some duplications were noted and those will be removed. Sami will make amendments as discussed and the committee agreed to use both the current guide as well as the new draft with the scoring coming up for several properties. It is the goal of the committee to vote on the new version at the March meeting.
- 5. **Executive Session** (1 MRS §405 6.C) John recused himself from the executive session. With a motion by Fred and a second by Dave the committee voted to enter into executive session. With a motion by Fred and a second by Chris the committee voted to come out of executive session. No decisions were made.

- b. Earth Day 2020 Sami reported on the Open Space activities being planned for this event. They include:

April Stools Day on April 18th from 10 -12:30 at FNP and possibly Community Park if we have a high number of RSVPs. Will be getting in touch with dog businesses regarding promotion and sponsorship.

Paul Larrivee is speaking on Falmouth Forestry practices on May 18th, 6 - 7 pm (location tbd)

Amanda has reached out to him to suggest an alternative project, the trail connection identified in NFCF from the new Orange Trail to the Hemlock Trail.
