Chair Farber opened the public hearing; there was no public comment.

Councilor Mahoney moved the order; Councilor Anderson seconded. Motion carried 7-0.

#### Item 6

Public Hearing on an amendment to the Zoning and Site Plan Review Ordinance to relax zoning provisions for the replacement of utility infrastructure.

Mr. Poore explained that this ordinance would relax setback standards for infrastructure improvements. It is difficult to locate those structures in the correct place and still meet setbacks. The need for this amendment was discovered during the planning for the redesign of the Mill Creek pump station,

Chair Farber opened the public hearing; there was no public comment.

Councilor Mahoney said wastewater pump stations would be exempt from setback requirements to the greatest extent practicable.

Amanda Stearns explained that there are two sections being amended; the first deals with the general setback requirements and the second deals with the shoreland zoning section. The current Shoreland Zoning table is not as clear as it could be in regards to how utilities are handled. This amendment would clarify how utilities such as culverts are treated in the shoreland zone, as well as treating essential services that are housed within a structure as part of the piping system instead of as a separate structure.

An order was scheduled for July 14.

#### Item 7

Order to authorize the Town Manager to amend the Capital Improvement Plan to eliminate the Fiscal Year 2018 expenditure for the replacement of lighting systems at Village Park in the amount of \$80,000 and add an expenditure in Fiscal Year 2015 in the amount of \$28,000 for parking lot and pedestrian scale lighting improvements at Village Park and furthermore, add an expenditure of \$33,000 for storm water quality treatment improvements and related expenses at Village Park and the associated parking lot in Fiscal Year 2015. (Note: these adjustments will result in a net savings of \$19,000 in the Capital Improvement Plan.)

Chair Farber explained that money was allocated in the CIP for lighting and infrastructure improvements in Village Park. This order would move those expenses to FY15 to correspond to improvements related to the Casco Bay hockey rink. This change will result in a net savings to the Town.

Councilor Goldberg asked if the item would remain in the CIP or be eliminated; Mr. Poore said it would be eliminated.

Councilor Anderson moved the order; Councilor McBrady seconded. Motion carried 7-0.

Public comment period opened. No public comment.

Councilor King moved the order; Councilor Hemphill seconded. Motion carried 7-0.

### Item 9 Discussion about future Council agendas.

Mr. Poore spoke about the Council retreat scheduled for July 18. He also discussed Council orientation.

Chair Farber said there is a public meeting at the library on Tuesday, June 24 at 6pm to review the design and costs for the library expansion.

### Adjourn

Councilor Hemphill moved to adjourn; Councilor Goldberg seconded. Motion carried 7-0. Meeting adjourned 7:51 pm.
