Councilor Kitchel moved the order; Councilor Svedlow seconded.

Councilor Farber said one of the renewals is for a mobile food cart. She was concerned about whether this specific business is in fact a mobile food cart.

Landing Market, Waldo's, Wal-Mart, West Falmouth Baptist Church.

Town Clerk Ellen Planer said the applicant is renewing the license from last year. There are no changes.

Councilor Farber said she has no problem with the business, and acknowledged that the ordinance in lacking in definition for mobile food establishments. This particular cart does not move, and has traditionally been in one place. She didn't think it passes the test as a mobile food cart. She acknowledged that these licenses expire as of June 30, and the Council doesn't meet again until July 10. She considered asking to pull this license out of the group, but also felt it wasn't fair to allow the license to expire. The business was licensed as a mobile food cart, but it functions as a regular brick and mortar store without having to meet the requirements of such. She felt this has created a backdoor, and it didn't seem fair to other businesses.

Councilor Svedlow pointed out that this business is functioning on the basis on past decisions.

Chair Hemphill wondered if they could renew the license for less than a year; Ms. Planer said she would have to look at the ordinance. Typically license renewals are for a year.

Mr. Poore said there was direction for the Ordinance Committee to work on this issue in last year's Council workplan. Staff issued a report to the Ordinance Committee, but other, higher priority items took precedence. Mr. Poore suggested putting it back on the Council workplan for this year. That would address the ordinance issue, but not the issue with this particular business.

Councilor Kitchel suggested they move forward with this license renewal, and revisit the mobile food truck issue during the year. He didn't feel they could deny the victualer license on this basis.

Councilor Farber asked if this business would be grandfathered if they amended the ordinance. Mr. Poore didn't think so, unless they wrote that provision into the amendment; the license is an annual renewal and the business would have to meet the requirements in effect at the time of the renewal.

Councilor Farber felt this business doesn't meet the current definition, but understood that there may be some ambiguity.

Councilor Ferrante has heard from some members of the public that agree with Councilor Farber.

Councilor Svedlow left the meeting.

Chair Hemphill opened the public hearing; there was no public comment.

Motion failed 3-2 (Farber, Ferrante)

Councilor Farber moved to reconsider the prior question; Councilor Kitchel seconded. Motion carried 5-0.

Councilor Farber moved to separate the application of Milly's Skillet from the order; Councilor Ferrante seconded. Motion carried 5-0.

Councilor Farber moved the amended order; Councilor Ferrante seconded.

Chair Hemphill opened a public comment period; there was no public comment.

Motion carried 5-0.

Councilor Farber moved to approve the application of Milly's Skillet; Councilor Kitchel seconded.

The Council discussed the food truck; it has not been at the site recently. Ms. Planer said the business owner concentrates on her location on Peak's Island in the spring and early summer; she was open in Falmouth most of last year.

Chair Hemphill opened a public comment period; there was no public comment.

Motion carried 5-0.

Item 4 Order to authorize the Town Manager to execute a quit claim deed for Map U61 Lot 019.

Councilor Farber moved the order; Councilor Kitchel seconded.

Chair Hemphill opened a public comment period; there was no public comment.

Motion carried 5-0.

Item 6 To approve the movement of the FY2017 Route One PACTS Paving Project in the amount of \$475,000 from the Route One South and Route One North TIFs to the Ocean View/Natural Gas TIF and to approve a supplemental appropriation from the Streets CIP Fund in the amount of \$250,000 for transfer to the OceanView/Natural Gas TIF Fund.

Mr. Poore said the OceanView/Natural Gas TIF will repay the CIP fund the full \$250,000; it is a young TIF and doesn't yet have a sufficient balance to cover this. The paving project was being carried by the Route One TIFs, but the auditors didn't feel that it qualified as a project under those TIF plans. It does qualify under the OceanView/Natural Gas TIF plan.

Councilor Farber moved the order; Councilor Ferrante seconded.

Chair Hemphill opened a public comment period; there was no public comment.

Motion carried 5-0.

Item 7 Order to change the date of 2017/2018 Council meetings impacted by holidays.

Councilor Kitchel moved the order; Councilor Ferrante seconded.

Chair Hemphill opened a public comment period; there was no public comment.

Motion carried 5-0.
