

## TOWN OF FALMOUTH ORDER NO 142-2017

## APPROVE THE SCHOOL BUDGET

## BE IT HEREBY ORDERED THIS 15TH DAY OF MAY, 2017, BY THE FALMOUTH TOWN COUNCIL, FALMOUTH MAINE, IN TOWN COUNCIL ASSEMBLED:

that the following school budget articles be adopted and approved for fiscal year 2017-2018:

- 1. That \$15,645,798 be authorized to be expended for Regular Instruction.
- 2. That \$4,906,803 be authorized to be expended for Special Education.
- 3. That \$97,929 be authorized to be expended for Career and Technical Education.
- 4. That \$1,017,864 be authorized to be expended for Other Instruction.
- 5. That \$3,339,201 be authorized to be expended for Student and Staff Support.
- 6. That \$867,606 be authorized to be expended for System Administration.
- 7. That \$1,395,688 be authorized to be expended for School Administration.
- 8. That \$1,462,538 be authorized to be expended for Transportation and Buses.
- 9. That \$2,630,325 be authorized to be expended for Facilities Maintenance.
- 10. That **\$4,430,863** be authorized to be expended for Debt Service and Other Commitments.
- 11. That **\$0** be authorized to be expended for All Other Expenditures.

**BE IT FURTHER ORDERED**, that \$25,980,734 be appropriated for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and that \$17,924,638 be raised as the municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as

described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688.

Explanation: The municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.

**BE IT FURTHER ORDERED**, that \$1,049,261 be raised and appropriated for the annual payments on debt service previously approved by the municipality's legislative body for non-state-funded school construction projects or non-state-funded portions of school construction projects in addition to the funds appropriated as the local share of the municipality's contribution to the total cost of funding public education from kindergarten to grade 12.

Explanation: Non-state-funded debt service is the amount of money needed for the annual payments on the municipality's long-term debt for major capital school construction projects that are not approved for state subsidy. The bonding of this long-term debt was previously approved by the voters.

The following order must be approved by a majority of the entire membership of the Council.

**BE IT FURTHER ORDERED**, that \$8,539,520 be raised and appropriated in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$8,036,914 as required to fund the budget recommended by the school committee.

The school committee recommends \$8,539,520 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$8,036,914: The state's funding model does not support all of the costs of the schools because it includes only those costs considered essential by the new State Essential Programs and Services (EPS) model.

Explanation: The additional local funds are those locally raised funds over and above the municipality's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the school department budget for educational programs.

The EPS funding model was originally designed to provide minimum funding expectations and equity for educational funding and was not designed to provide full funding for a complete educational experience. The model does not adequately recognize the full costs associated with delivering the educational experiences that the Falmouth community values and the Falmouth Public Schools provide. Costs not adequately represented or included in the EPS model (formulas) that contribute to exceeding 100% of the EPS model include, but are not limited to, professional staff salary and benefit costs (not reflective of market conditions or number of personnel needed to deliver the Falmouth educational program (RTI, unified arts, world languages, literacy, class sizes, high school

electives/college prep/AP offerings, etc.), athletic and co-curricular activity costs, substitute teacher costs, the cost of additional student days, accurate facility maintenance and repair costs, and energy cost variances beyond the rate of inflation.

**\$35,794,615** for the fiscal year beginning July 1, 2017 and ending June 30, 2018 from the municipality's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

**BE IT FURTHER ORDERED**, that in addition to the amounts authorized under the previous orders, the Council hereby authorizes the school committee to expend any state, federal and other grants, aid and receipts during the fiscal year beginning July 1, 2017 and ending June 30, 2018, for school purposes and adult education, provided that such grants, aid and receipts do not require expenditure of local funds not previously appropriated.

**BE IT FURTHER ORDERED**, that in the event that the Falmouth Public Schools receive more state education subsidy than the amount included in its budget, the School Committee is authorized to use all of the additional state subsidy to **decrease the local cost share expectation**, as defined in Title 20-A, section 15671 - A(1)(B), for local property taxpayers for funding public education as approved by the School Committee.
