## An Ordinance Amending the Code of Ordinances Regarding Car Washes in the VC Districts

Be it ordained by the Town Council of the Town of Falmouth, Maine in Town Council assembled, that the Falmouth Code of Ordinances Chapter 19, Zoning and Site Plan Review Ordinance, be amended to read as follows, with an effective date of May 15, 2017:

## Add a new definition:

**Car Wash:** An establishment engaged in the washing of motor vehicles.
