Hi Everyone,

I just wanted to alert you to a looming orthoimagery deadline. If you would like to order aerial images for your community for this year (flown this Spring) you need to submit your order to the Maine Orthoimagery Program by March 15th. That said, the program needs at least \$200k of aerial imagery requests to do a flight. Waldo County has committed (\$42k) and it's possible that Aroostook County and 14 unorganized territories will commit. In that case they would have enough requests to do a Spring 2021 flight. If not, everything rolls over to the next year (Spring 2022). Attached is an overview of the program. Below are links to the program's website and a pricing sheet for Cumberland County municipalities. If your municipality would like to get in on the Spring 2021 flights (if they happen) please contact Claire Kiedrowski (Cc'd and contact info below) as soon as possible. (Claire feel free to follow up with any updates or if I mischaracterized anything here).
