
# Paper Streets Introduction May 2017



Paper Street: A road depicted on a recorded subdivision plan, but which has never been built or accepted (by the town) as a public

way.



## Access/Rights:

There are public and private rights in paper streets. Maine law dictates the nature of those public and private rights, the termination of those rights, and mechanisms for determining who owns the land "under" the paper street.

The Town's focus is solely on certain public rights that will automatically expire if the Town takes no action prior to September 15, 2017

Public Rights: The recording of a subdivision plan is generally considered a dedication to the public to accept or use the streets shown on the plan as public ways. Conversely, Vacating a paper street extinguishes these rights.

<u>Private Rights</u>: All lot owners in the subdivision generally acquire private rights-of-way over all the roads depicted on the plan (These rights <u>may</u> continue even if the town vacates the paper street).

### **Summary of Process**

For municipalities that exempted certain unaccepted ways, or paper streets, from being deemed vacated by operation of law, the 2017 deadline for the next and final 20-year extension is approaching. According to Maine law, a proposed, unaccepted way laid out on a subdivision plan recorded prior to September 29, 1987 is deemed to have been vacated if by September 29, 1997 (or 15 years after the subdivision plan is recorded, whichever is later) the way has not been constructed, used or accepted as a public way or easement.

The law provides one exception to that rule: municipalities may prevent an automatic vacation by filing a notice of extension in the registry of deeds. Municipalities may file for an additional 20-year extension by filing a new notice prior to the expiration of the first 20-year period.

### What This Means for Municipalities:

Extensions that were filed in 1997 will expire in 2017. Affected municipalities have until 2017 to review the list of paper streets that were saved from automatic vacation and determine which, if any, of those proposed ways should be saved from vacation for an additional 20 years.

## NOTICE TO EXTEND DEADLINE OF AUTOMATIC VACATION OF "PAPER STREETS" 23 MRSA ss 3032

#### TOWN OF FALMOUTH

This Notice is made pursuant to 23 MRSA ss 3032. After due consideration, the municipal officers of the Town of Falmouth hereby vote to except from the operation of the time limitations of ss 3032 the proposed, unaccepted ways (commonly known as "Paper streets"), or portions thereof, which are described on the sheet attached hereto and incorporated herein as Exhibit "A".

This vote extends, for a period of twenty (20) years from the recording of this Notice, the time in which the ways described in Exhibit "A" will be subject to the operation of ss 3032. During that 20-year period, the rights of incipient dedication to public and private use of such ways shall remain in effect unless otherwise terminated or accepted in accordance with law.

## Town's Options with Regards to Paper Streets:

- Do nothing and allow the paper street to be deemed vacated as of September 15, 2017
- Extend the incipient public rights in the paper street for another 20 years
- Accept the paper street and construct a public road
- Accept lesser easement rights in the paper street, such as for recreational use by the public and/or utilities

## Next Steps:

- Continued Staff and Legal Reviews of each paper street (May)
- Staff Provide Recommendations for Town Council Consideration (July)
- ➤ Hold a Public Hearing to inform the public (July)
- Council Action (Order) on Paper Streets (August)
- Council Order Recorded at the Registry prior to September 15, 2017
