Why isn't Blackstone road a short term priority? There are large cycling groups that use Blackstrap and Mountain Rd. and the condition of the roads in that area are terrible.

Hi Kim: Thanks for writing. We'll convey your suggestion to Town Council.

In the meantime, you may want to review pages 127-129 in more detail. That attachment represents our effort to take the feedback we got from everyone (136 people) on all actions and develop some sense of priority, as not everything can be a short term priority.

This is what we learned for action 46 Blackstrap Road:

Stakeholder score: 2.15 Medium range: 2.05-2.44
Forum score: 2.38 Medium range: 2.00-2.40
Survey score: 1.94 Medium range: 1.90-2.10
Average score: 2.16 Medium range: 2.00-2.25

So, you see it fell consistently in Medium range, which is where the CDC decided to keep it.

This [priority] is not the end-all-be-all of course, but gave us a sense of direction. Hope this gives you a sense of how we arrived at that.

Hi, if it went by vote was there consideration for rider safety? Blackstrap road in Falmouth is in terrible shape. When you cross over the surrounding town lines the road actually improves. I'm not a cyclist, but have noticed for years that riders have to be in the middle of the road to avoid the tire ruts and road damage. And there is no shoulder at all on the road, with most of the edges in disrepair as well. Does the town of Falmouth determine where road improvements take place?

The town spent a small fortune on Rt. 1 improvements and I've seen very little as a result of those. Blackstrap gets a lot of cycling traffic - cyclists seem to prefer the more rural side of Falmouth for long trips - yet Blackstrap gets worse every year and nothing is done. Does this have to do with the east part of town having more residents and higher earnings?
