Re: Proposed Draft Revisions to 2013 Comprehensive Plan

Town staff recommends that the Council consider adopting a revised Comprehensive Plan.

- The proposed plan revisions are made in response to review comments received by the State of Maine.
- The State of Maine has found the plan, with inclusion of the proposed revisions, to be complete and consistent with the Growth Management Act.
- Staff believes that these revisions are non-substantive and do not require a Public Hearing.
