1.1 PROJECT INFORMATION

- D. Project Description: The project consists of exterior envelope repairs, interior space reconfiguration, and site work. The existing siding, windows, and doors will be removed (including asbestos shingles) and new rigid insulation, clad wood windows, fiber cement siding, and hollow metal doors and frames installed. Interior office space will be reconfigured, with miscellaneous partition removal, finish removal, and ceiling reconfiguration. New gypsum board partitions, doors and frames, finishes, and ceilings will be provided. All related mechanical, electrical, plumbing, and structural supporting work to facilitate the improvements will be included.
