To the Town of Falmouth councilors and residents,

It is our intent to open a seasonal farm to table restaurant and event space in the barn at Smith Farm, located at 226 Gray Rd, Falmouth, Maine. The Barn at Smith Farm will be open April through November. We would like to start this summer serving dinner three nights a week and expand to five nights by next summer. We would like to host private events on the weekends as well as some of our own special events such as lobster bakes, pig roasts, pop up dinners, and seasonal feasts.

We will offer a farm to table dining menu by reservation as well as a bar menu including burgers, sandwiches and salads for walk in customers. We have a bar and will be pursuing a liquor license. We will offer indoor and outdoor dining. Our style is simple rustic elegance. We grow much of our own produce at the farm and source meats, seafood and produce from farms in Southern and Western Maine.

We have worked to revitalize Smith Farm over the past three years. For those not familiar, Smith Farm was a long running Falmouth restaurant with a great history and reputation from the 1960's through the 80's. We are thrilled with the opportunity to bring it back to life. The property has been tidied up, renovated, and freshly painted. We hope to become a land mark in Falmouth showcasing the southern end of Falmouth's Hurricane Valley Farming District. It is our intention to work with other farms along this stretch to preserve and rejuvenate this particular stretch of Rte 100. Thank you for your consideration.
