Victualer/Food Service Establishment License

What is needed to Apply:

- Letter of intent, addressed to the Members of the Town Council;
- Town of Falmouth application for a New Food Service Establishment License;
- Copy of State License;
- Town of Falmouth Special Amusement application for entertainment (if applicable);

No licensee for sale of liquor to be consumed on the premises may allow any live music, dancing or entertainment of any sort. "Entertainment is defined as "any amusement, performance, exhibition, or diversions for patrons or customers of the licensed premises, whether provided by professional entertainers or by full-time or part time employees of the license whose incidental duties include activities with an entertainment value.

- State application for alcohol (including Corporate Supplement, if applicable); this application must be signed by the Municipal Officers of Falmouth before sending it to Augusta for your State license.
 - Payment of all fees, including all taxes pertaining to the premises.
- *The application must be complete in order to be accepted and processed.
- *Applications must be submitted at least four (4) weeks prior to the Council meeting.
 - All new food establishments require a Public Hearing.
 - Once the complete application packet and fees are received, the notice for a public hearing will be placed.
 - The public hearing and the new license application will be put on the Town Council agenda for review/approval by the Falmouth Town Council.
 - You will be required to attend the Town Council meeting

The Council meets on the 2nd and the 4th Monday of each month, (except holidays) and the month of June. If the Town Council approves your application for a new Food Service Establishment the Town Clerk's Office will issue a Victualer/Food Establishment License.

What the Applicant Should Do:

You will need to obtain a State of Maine Food Service License. That license can be obtained by contacting the Department of Health and Human Services (DHHS) at 207-287-5671.

<u>For State Liquor Licenses</u> visit the Liquor License and Compliance Division, Department of Public Safety at: http://maine.gov/dps/liqr/applying.html or Call 207-624-7220. They can then tell you what class license you should apply for. The Falmouth Town Council must approve and sign your application before you send the application, along with the appropriate payment, to the Department of Public Safety in Augusta.
