

Dear Falmouth Neighbors,

It's hard to believe October is already upon us and signs of Fall are

everywhere. The Council was hard at work over the Summer. In addition to Town Council and Committee meetings, Councilors gathered on July 20 for our annual "work plan retreat" to establish priorities and set goals for FY22-23.



As most residents are aware, Falmouth just completed a full revaluation of all real property. Please take a moment to read the articles on pages 2 and 3 of this newsletter about the revaluation, the new mil rate, and several tax assistance programs and exemptions available to property owners and especially to seniors. FALMOUTH REVALUATION PROJECT

Falmouth completed its townwide revaluation in August. At the Town Council meeting on August 8, Assessor Ben Thompson presented an update on the revaluation, accompanied by David Cornell, an independent consultant hired to provide a quality review of the revaluation and analytics of the data collected. The analytics help to explain shifts in tax burden and market impacts on certain types of properties. According to Mr. Cornell, Falmouth's revaluation meets all industry standards for complete and accurate data and effective valuation models.

Through the revaluation, Falmouth's taxable assessments increased by approximately \$1.59 billion, an increase of approximately 61.7%. The bulk of that increase, approximately 66.45%, was in residential assessments. While commercial assessments increased, they



did not increase at the same rate as residential values.

The increased townwide valuation of taxable properties resulted in a decrease of the mil rate from 17.43 to 11.92.

While the informal appeals process has been completed, property owners who still disagree with the newly assessed value of their property have 185 days after the tax commitment to file an abatement with the Assessor's Office.

Property tax bills will be mailed out in late September and the deadline for the 1st payment is November 3, 2022.

FY22-23 Mil Rate 11.92

Calculating Your Property Tax

Multiply your new assessed value by the new tax rate.

New Assessment x .01192 = Property Tax For example, \$500,000 x .01192 = \$5,960

Note: This calculation does not include exemptions for which you may qualify that could lower your bill.

NOVEMBER 8 GENERAL ELECTION

The Clerk's Office is accepting requests for absentee ballots for the November 8 General Election. Absentee ballots will be mailed out 30 days prior to the election. Any registered voter may cast an absentee ballot instead of voting in person on Election Day. There are four ways to request an absentee ballot:

- Mail: Print an Absentee Ballot Request Form at: www.falmouthme.org and mail to

Falmouth Town Hall.

• In Person: Request a ballot at Falmouth Town Hall.

The deadline to request an absentee ballot is November 3. The Clerk's Office will offer extended hours for absentee voting on Thursday, November 3.

On Election Day, voting will take place from 7am-8pm at the Falmouth High School Gymnasium, 74 Woodville Road. No voting takes place at Town Hall. The Clerk's Office will be closed on Election Day to facilitate the election.

PROPERTY TAX ASSISTANCE

Are you taking advantage of all the property tax exemptions, programs, and assistance available to you?

STATE EXEMPTIONS

Homestead Exemption—Provides a reduction of up to \$25,000 in property tax relief for certain individuals that have owned homestead property in Maine for at least 12 months and make the property they occupy on April 1 their permanent residence.

Renewable Energy Investment Exemption—Exempts renewable energy equipment, such as solar panels, from property tax beginning April 1, 2020.

Veteran Exemption—Available to Veterans 62 years or older; or, receiving 100% disability as a Veteran; or, became 100% disabled while serving.

Paraplegic Veteran—Available to Veterans who received a federal grant for a specially adapted housing unit.

Blind Exemption—Available to individuals who are determined to be legally blind.

PROGRAMS FOR SENIORS

The Town of
Falmouth offers
Senior Property
Tax Assistance to
residents who meet
the following
criteria:

- Age 62 or older
- Household income below \$60,000 per year
- Current resident of Falmouth (owner or renter)

Refunds are determined based on the number of valid applications received. Recipients will be refunded a



proportional share of the available program funds based on income level.

Property Tax Stabilization for Senior Citizens is a State program that allows certain senior residents to freeze the property taxes on their homestead. An applicant must be:

- Age 65 or older
- A permanent resident of Maine
- Owned a Maine homestead for at least ten years
- Eligible for a homestead exemption on the property they are placing in the program

Applications must be filed annually. **The deadline is December 1, 2022.** The law goes into effect in 2023. The property tax for your homestead will be frozen at the amount you were billed the prior tax year. *For applications*

received in 2022, this means that the amount that appears on the tax bill you receive in October 2022, which is your tax bill for July 1, 2022-June 30, 2023, will be the frozen amount going forward. For additional

PUBLIC SAFETY ALONG THE PRESUMPSCOT RIVER

Falmouth Public Safety would like to remind residents of the very real danger of drowning to both people and pets in the strong currents of the Presumpscot River. While many people take advantage of the hand-carry canoe and kayak water access from Walton Park, the river trail access from Presumpscot Falls Park, as well as Portland Trails and private property fronting the river, users should be aware that the currents (including river and tidal) are strong and fast moving making it very dangerous, even for skilled swimmers, kayakers, and other recreationalists. The Town of Falmouth is working with Portland Trails to increase warning signage (see example at right) at several access points and to enhance education and outreach to the public regarding the dangers of the river currents.

The National Park Service advises us that swimming in natural waters such as




rivers is very different from swimming in a swimming pool. Currents can tire you out and sweep you away. Distance across water is greater than it looks. Cold water can shock your body and make it difficult to swim. Water depth can suddenly change to above chin level. Underwater hazards like trees and rocks can trap you and keep you from swimming back to shore. Residents are advised to keep this in mind and use caution when recreating along the Presumpscot River.

ROAD CONSTRUCTION UPDATE

Construction continues along Middle
Road to the Woods Road roundabout as
part of the West Falmouth Sewer
Project. Work will then proceed up
Woods Road and into The
Woodlands. No additional road
closures are anticipated during the
project but travel will be reduced to
alternating one lane north of Bucknam

Road. We appreciate your continued patience and caution when driving through the construction zone.

Additionally, MaineDOT's Bucknam Road Bridge Replacement Project is scheduled to begin this Fall. This will cause significant disruption to traffic. Updates will be provided via E-Alerts, social media, and our website.
