# Town of Falmouth, Maine Request for Proposals Invasive Plant Roadside Remediation March 2018

The Town of Falmouth, Maine seeks qualified contractors to eradicate roadside terrestrial invasive plants within the public right of way, on Town properties, and possibly on residential properties. The Town has recognized over the years the damage that invasive species have done on natural ecosystems. Their excessive growth degrades ecosystem diversity for both flora and fauna, and certain invasive plants can harbor more ticks that can cause diseases. Falmouth is committed to eliminate invasive plants and seeks a qualified commercial applicator to assist in these efforts with the use of herbicides.

# Background, Most Current, and Future Efforts

Much of this work is done under the auspices of the Town's Conservation Commission with staff support from the Sustainability Coordinator. More than a decade of education and outreach has been conducted through the Commission on the negative effects of invasive plants. The invasive plants that have been predominantly identified, targeted, and treated include barberry, bittersweet, buckthorn, honeysuckle, Japanese knotweed, multiflora rose, and burning bush.

Previously treated properties are resurveyed annually to locate plants that were missed or where regeneration has occurred. *These areas will be inventoried in April-May and will need to be re-treated as necessary.* More details on these areas are attached as Appendix B and C.

In the spring, large dead plants that were previously treated along the roadside will be mowed by the Town's Public Works Department.

# Past year roadside treatments have been mapped and provided as an attachment in Appendix A.

# Annual Cycle

- 1. The target areas are mapped by Town volunteers and the selected contractor in the fall and spring by driving each road and noting invasive types and locations by address. Properties in which invasive plants go beyond the roadside are also identified.
- 2. The Town mails a letter in late May to property abutters whose properties will be treated based on efforts in the previous step.
- 3. The Town holds a public meeting in June to explain the work and how it will be done. Homeowners who want invasives controlled on their properties are also identified at this time.
- 4. A reminder postcard is sent out by the Town in August before treatment occurs in mid-September.

# Details and Specifications to be included in a Statement of Qualifications

The Town reserves the right to reject any proposal that does not meet the following qualifications:

- 1. A State of Maine Commercial Pesticide Applicator's License is required.
- 2. Availability to perform work in September 2018.
- 3. Extensive knowledge of invasive plants and the ability to identify them accurately.
- 4. The scope of this work will be done through maps, identified targeted areas, and coordination with Falmouth's Conservation Commission and with staff supervision by the Sustainability Coordinator.
- 5. Adequate staff and equipment (including an equipped truck for high volume spraying) to ensure efficient and safe performance of roadside work, including the ability to manage traffic as necessary. Provide a list of employees with qualifications who would be assigned the work.
- 6. Ability to speak to stakeholders at a public forum, scheduled for June 19, 2018, at 6:30 pm in Falmouth. The rationale is to alleviate concerns and present information in a clear and compelling way to the public about the program.
- 7. Flexibility in scheduling the work, as some of it may be weather dependent.
- 8. Willingness to work with town volunteers and staff on these efforts, and to work diligently and respectfully with others.
- 9. Willingness to offer treatment to residents on private property where invasives have grown beyond the roadside, and if this would be included in the costs or would be an additional cost (optional).

10. References and examples of similar work, including the contact information of the person who directly managed the contract.

# In bidding on this work, the contractor must provide in his or her Proposal and agree to the following:

- 1. A quote breaking out all the costs for both the labor/crew/travel to conduct the work, as well as the costs associated with the chosen herbicide.
- 2. The contractor shall invoice the Town for payment no later than 30 days after the work is completed.
- 3. The selected contractor shall enter in the Town's standard contract agreement, which is attached in Appendix D.
- 4. A copy of the contractor's liability insurance and workers' compensation coverage, as required in the standard agreement.
- 5. A detailed methodology of targeting invasive terrestrial plants, while minimizing the impacts to native plants.
- 6. A copy of his or her State of Maine Pesticide Applicator's License, including the commercial master applicator and/or any commercial operator applicator license(s).
- 7. The contractor will provide the name of the chosen herbicide to conduct this work, an explanation for the herbicide(s), the EPA registration number, the Safety Data Sheet (SDS), and any other warranted information associated with the chosen herbicide the Town requests.



#### AGREEMENT

### I. PARTIES

This contract (hereinafter referred to as "Agreement") is made and entered into on this \_\_\_\_\_\_day of \_\_\_\_\_\_, 201\_\_, by and between the Inhabitants of the Town of Falmouth with a mailing address of 271 Falmouth Road, Falmouth, Maine 04105 (hereinafter referred to as "Town"); and \_\_\_\_\_\_, with a mailing address of \_\_\_\_\_\_\_, hereinafter referred to as "Contractor"). In consideration of the mutual promises contained herein, Contractor agrees to perform

the following services for the Town.

### II. SCOPE OF WORK

In consideration of the compensation set forth herein, the Contractor shall perform the services as outlined in a request for proposal dated \_\_\_\_\_\_ and attached hereto as Exhibit A and the response attached hereto as Exhibit B.

#### **III. COMMENCEMENT AND COMPLETION**

The Contractor will commence work on or before \_\_\_\_\_\_, 201\_\_\_\_, and will complete work on or before \_\_\_\_\_\_, 201\_\_\_.

#### IV. PAYMENT TERMS

The Contractor shall submit an invoice on or about the first of each month reflecting services performed at the Contractor's normal professional billing rates, attached hereto as Exhibit C. The Contractor understands that the payment for completion of the services outlined in Section II shall not exceed \_\_\_\_\_\_

Dollars (\$\_\_\_\_\_), and the Contractor agrees to perform the services on that basis. Invoices shall list separately all out of pocket expenses being billed.

#### V. TERMINATION

Either party may terminate this Agreement for cause after giving the other party written notice and a reasonable opportunity to cure. The Town may terminate without cause by giving the Contractor fourteen (14) days notice, and compensating the Contractor equitably to the termination date.

#### VI. DISPUTE RESOLUTION

Any controversy or claim arising out of or related to this Agreement, which cannot be resolved between the parties shall be submitted to the Maine Superior Court (Cumberland County). This agreement shall be governed by Maine law.

#### VII. QUALIFICATIONS

The Contractor represents it holds, and will continue to hold during the term hereof any and all qualifications, licenses and certifications required to perform its services in Maine. The contractor shall perform all services in accordance with professional standards.

#### VIII. SUBCONTRACTORS

The Contractor shall be fully responsible to the Town for the acts and omissions of any subcontractors, and of persons either directly or indirectly employed by it, and shall hold subcontractors to the same terms and conditions as Contractor is held under this Agreement. No subcontractors shall be retained on this Agreement without the specific prior written approval of the Town.

#### IX. INSURANCE

The Contractor shall purchase and maintain Workers' Compensation Insurance, General Public Liability and Property Damage Insurance including vehicle coverage and professional liability insurance, all with limits and terms satisfactory to the Town. The Town shall be named as an additional insured on the liability policy.

## X. INDEMNIFICATION

The Contractor will indemnify and hold harmless the Town, its officers, agents and employees from and against all claims, damages, losses and expenses including attorney's fees arising out of or resulting from the performance of the Agreement by the Contractor, its officials, employees, agents and subcontractors.

### XI. ENTIRE AGREEMENT

This Agreement and its attachments represent and contain the entire agreement between the parties. Prior discussions or verbal representations by the parties that are not contained in this Agreement and its attachments are not a part of this Agreement. Where there is any conflict between the provisions of this Agreement and the provisions of any attachment, the provisions of this Agreement shall control.
