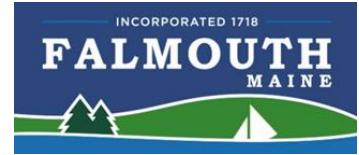

The Falmouth Public Works Department is requesting bids for the purchase of a 2020 or 2021, Ford Explorer XLT/Police Interceptor, Chevrolet Equinox LT, or Equivalent Make/Model, 4WD/AWD, SUV.

Sealed bids shall be submitted by **11:00 AM on Tuesday, April 27, 2021.**

Full compliance with details of these specifications is mandatory prior to the final acceptance of the vehicle and equipment by the Town of Falmouth. These specifications require the doing of all-necessary, as for, or incidental to the furnishing and delivery of said vehicle and associated equipment. All things not expressly mentioned in these specifications but involved in carrying out their intent are required by these specifications and the vendor shall perform the same as though we specifically mentioned, described and delineated.

The vehicle and all associated equipment shall be furnished complete and in readiness for use, as required by the terms of these specifications and strict accordance therewith. The vehicle shall be delivered to the Town no later than September 30, 2021.

The unit and all equipment furnished shall be manufacturer's latest listed and published stock model, which meet all applicable requirements of these specifications. All design, materials and workmanship, shall in every respect, be in accordance with the best current practices in the industry and all materials used shall be new.

Equipment must be completely inspected and serviced by the vendor prior to delivery.

Specifications for 2020 or 2021, Ford Explorer XLT/Police Interceptor, Chevrolet Equinox LT, or Equivalent Make/Model, 4WD/AWD, SUV.

The following descriptions and minimum specifications will apply:

1. Axle-Front, standard for model
2. Axle-Rear, Standard for model
3. Brake System, standard for model with 4-wheel anti-lock brakes
4. Color, truck to be painted in manufacturer's Red
5. Cab and Body:
 - a. Standard cab features, all steel construction with tinted windshield and safety glass. Rear bumper, including pad, dark pewter interior, cloth seats, insulated vinyl floor mats, center console, dual sun visors, intermittent wipers, Air conditioning.
6. Electrical, standard for model, all electrical to be wired to ignition system
7. Fuel System, standard for model or hybrid engine (Alternate/ Additional Option)
8. Manuals: standard driver, Maintenance for engine and chassis, Electrical.
9. Suspension System, standard for model.
10. Steering System, hydraulic power system
11. Switches and Gauges, standard for model
12. Transmission, 4 speed automatic heavy duty with cooler
