

Request for Proposals Pipe Inspection Camera Town of Falmouth, Maine January 12th, 2022

The Town of Falmouth is requesting bids for the purchase of a pipe inspection camera per the enclosed specifications. The pipe inspection camera will be used by the Public Works Department for video inspections of the Town's storm drain infrastructure.

Sealed bids shall be submitted to the Town using the enclosed bid form. Bids shall be submitted by Wednesday, February 2nd, 2022 at 11:00 AM at the Falmouth Public Works building located at 101 Woods Road, Falmouth, ME 04105.

Proposals shall be submitted in sealed packages labeled "RFP – Pipe Inspection Camera, Attn: Justin Early."

All pre-bid correspondence shall be submitted to Justin Early, Town Engineer, at <u>jearly@falmouthme.org</u> or at 207-781-3919. Questions regarding this bid/proposal shall be accepted until 5:00 PM, Monday, January 31st, 2022.

Vendors are allowed to submit more than one bid.

1. RFP OVERVIEW


The Town of Falmouth is looking to expand its asset management and maintenance program by purchasing a Closed-Circuit Television (CCTV) pipe inspection camera to perform condition assessments on its storm drain infrastructure. The inspections will be used to help prioritize infrastructure maintenance while meeting Municipal Separate Storm Sewer System (MS4) environmental permit requirements.

Minimum Required Product Specifications:

- The camera shall be able to inspect storm drain pipes ranging in size from 8-inch diameter to 36-inch diameter
- The camera and associated equipment shall be portable with protective cases included (the Town does not intend to use the camera with a stand-alone inspection truck)
- The camera shall be a submersible crawler type
- The cameral shall have pan, tilt and zoom capabilities
- Minimum 1-year warranty on parts and labor is required


2. PRODUCT SUMMARY

Responding vendors are required to submit a "product summary" that specifies the product name and/or model number and fully describes the product being submitted for consideration. This can be done via separate document, brochure, flyer, etc. but must fully describe the capabilities and functions of the inspection camera. The product summary can be submitted as a hard copy or on an electronic thumb drive and must be submitted with the price proposal. The summary shall, at a minimum, include the following information:

• Camera

- Pipe Size minimum and maximum pipe diameters that can be inspected and minimum and maximum pipe sizes that the camera head can be centered in.
- Pan, tilt and zoom capabilities
- Rear camera (specify standard, not included or optional)
- Elevating arm (specify standard, not included or optional)
- Power supply and available operating time
- Wheel Options
 - o Size
 - o Material
 - Steerable (specify standard, not included or optional)
 - Tracks (specify standard, not included or optional)
 - Spacer kit (specify standard, not included or optional)
- Tether
 - o Length/Range
 - Tracking distance (specify standard, not included or optional)
 - Powered reel (specify standard, not included or optional)
- Handheld controller and viewing screen information
- Software integration capabilities (include name of compatible software options)
- Other add-ons or optional equipment
- Complete product specifications
- Warranty information
- Technical and troubleshooting support offered
- Approximate availability date

The Town will determine the need for demonstrations after a review of the submitted proposals is complete. The Town will coordinate with selected vendors on a time and format for such sessions. If demonstrations are requested, these may be done either in person or remotely.
