I am writing to you regarding the meeting tonight on the use of the Brown Property. I own the property (262 Foreside Road) next to the Brown Property. I believe it makes sense to improve the lot in terms of additional flowers, bushes, trees, paths, etc and to improve/replace the existing playground equipment. I understand that this would also include improving the existing parking area, which makes sense to me.

What I am not in favor of is the potential creation of additional parking that would encourage greater use of the waterfront. Given that over the past decade the temperature of the Gulf of Maine has warmed faster than 99% of the global ocean, we need to take climate change seriously. While perhaps unpopular, I would like to discourage the use of the local (non-working) waterfront. Thank you for your time and consideration. Hello Maggie,

We are writing in regards to the Underwood Park Improvement Project. We were unable to attend last night's meeting, but have heard from neighbors, some of the potential options that were discussed. My family resides at 252 Foreside Rd, which directly abuts Underwood Park. We are very supportive of enhancements to the facilities at Underwood Park and are appreciative of the Town's desire to make improvements, while balancing community member concerns.

We understand there is consideration being discussed of expanding the existing parking area from its current 3 spaces to 20+ spaces. This raises a significant concern for our family given the proximity of our dwelling to the existing parking facility. The existing parking area is no more than 10 feet from the structure of our home. The current parking facility involves the limited number of cars parking on the opposite side of the drive circle from our home, facing the park itself and is not a disturbance to us. We are concerned about the potential expansion of the existing parking lot to accommodate 20+ cars, as that may involve cars potentially being parked facing our home (and approximately 10 ft away from it). The potential disturbance from noise, car headlights shining into our home and general privacy, is concerning to us given the very short distance between our home and the parking area.

We understand that there is a potential alternate location for the expanded parking on the northern side of the park, which would not have a dwelling in such close proximity to its proposed location. We would strongly encourage the Town to consider this location for any expanded parking that is needed, rather than the location which is in such close proximity to our residence.

Again, we are very supportive of the efforts that the Town is making to improve the park facilities, but wanted to share our particular concern with the parking area. We would be happy to discuss this with you further.
