
Background:

- The Ordinance Committee began discussing short-term rentals in 2018 after residents had contacted Councilors.
- In the 2019-2020 Council work plan, the Council directed the Ordinance Committee to explore options surrounding the development of short-term rental regulations.
- Town staff conducted research on the shortterm rental landscape in Falmouth as well as Maine municipalities and select national municipalities' short-term rental ordinances.
- This research was presented at the January 13, 2020 Council meeting.
- At the meeting, the Council directed staff to hold a public forum.



Short-term Rentals in Falmouth

- Host Compliance Data as of November 2019
 - 144 listings, representing **122 unique rental** units
 - Median Nightly Rate-\$195
 - 80% Single Family Home, 15% Multi-Family Home, 5% Unknown Home Type
 - **78% Entire Home, 21% Partial Home**, 1% Unknown Room Type
 - The number of short-term rental listings in Falmouth has increased 27% over the last year (113 to 144)
 - The number of unique rental units has increase 31% since last year (93 to 122)




