

LONG RANGE PLANNING ADVISORY COMMITTEE - 2010 "MINI" SURVEY RESULTS (November 16, 2010)

The Long Range Planning Advisory Committee conducted this initial, informal 3-question survey among Falmouth residents from June-October 2010. The purpose of this survey was to learn more about the perceived qualities of Falmouth and issues that residents felt needed improvement. In addition, the survey made residents aware of the current effort by a citizen committee to draft a new Comprehensive Plan that will guide Falmouth's decision-making over the next ten years or so. A total of 553 responses were received. The feedback obtained by this survey will is being used by the committee in the development of a statistically-valid community survey that is expected to be conducted in early 2011. Falmouth has kept an eagle eye on ways to improve and keep up with the increasing demands of its growing population. However, I believe Falmouth deserves a 10, when considering all the variable. But, I 'd like to see the removal of dead, old trees along a few roadsides, improvements on the perimeters of a few of the old cemeteries, and, perhaps, one lovely garden in each that is on a road often traveledto honor past Falmouth inhabitants; and the New Casco Fort monument "prettied up" for Memorial Day each year (and a small wrought iron fence around it to protect such a garden from the crowds on Memorial Day.)
